2. ABOUT OUR COLLEGES

The M.Sc. Nursing Programme is based on sound educational principles which make provision for continuous development of the student as an individual, a citizen and a professional nurse. The college aims at providing desirable behavioral changes in the students which are brought about by meaningful experiences within a climate of mutual respect and understanding. The course in the physical and biological sciences helps them to understand the scientific principles of nursing. The study of social and behavioral sciences helps them to understand their clients with varied socio-economic and cultural background.

2.1 SHRI VINOBA BHAVE COLLEGE OF NURSING, SILVASSA

Shri Vinoba Bhave Civil Hospital, Silvassa earlier known as Cottage Hospital was started in the year 1952 with minimum OPD services and Indoor facility. This hospital after renovation is named as “Shri Vinoba Bhave Civil Hospital, Silvassa” and rededicated to the people on 01/07/1999. It is 600 bedded multi-specialty teaching hospitals, catering the health needs of population in Dadra & Nagar Haveli and surrounding areas of Gujarat and Maharashtra.

Shri Vinoba Bhave Civil Hospital took an initiative of starting a School of Nursing in the year 2008 with an aim to uplift the tribal girls through nursing education. The school was upgraded to College of Nursing with Basic B.Sc. Nursing in the year 2013 with an annual intake of 40 students which was increased to 60 in the year 2016 and admits Super numerary quota of 10% of seats under Economically Weaker Section (EWS) and 8 seats under Pradhan Mantri Special Scholarship Scheme (PMSSS) from the year 2021 onwards. The M.Sc. Nursing course was started in 2016 with an annual intake of 20 seats, with 5 major specializations and admits Super numerary quota of 10% of seats under Economically Weaker Section (EWS) from the year 2021. The courses are academically affiliated to Veer Narmad South Gujarat University, Surat and recognized by Gujarat Nursing Council, Ahmedabad and Indian Nursing Council, New Delhi.

2.2 GOVERNMENT COLLEGE OF NURSING, DAMAN

Government Hospital, Marwad, Daman was started in the year 1952. It is a 185 bedded multi-specialty hospital which caters the health needs of population in Daman and surrounding areas of Gujarat. The up-gradation of the hospital to 300 bed strength is under progress. The Directorate of Medical and Health Services took initiative of starting a College of Nursing at Daman with Basic B. Sc. Nursing programme in the year 2017 with an annual intake of 50

students and admits Super numerary quota of 10% of seats under Economically Weaker Section (EWS) and 8 seats under Pradhan Mantri Special Scholarship Scheme (PMSSS) from the year 2021 onwards. The M.Sc. Nursing course was started in 2021 with an annual intake of 20 seats, with 5 major specializations. The courses are academically affiliated to Veer Narmad South Gujarat University, Surat and recognized by Gujarat Nursing Council, Ahmedabad and Indian Nursing Council, New Delhi.

4. CORE VALUES

6. DETAILS ABOUT THE COURSE OF STUDY: M. Sc. NURSING (2 Years)

6.1. ADMISSION REQUIREMENTS

- a. The candidate should be a Registered Nurse and Registered midwife or equivalent with any State Nursing Registration Council.
- b. Minimum educational requirements shall be the passing of: Basic B.Sc. Nursing / B.Sc. Hons.Nursing / Post Basic B.Sc. Nursing with minimum of 55% aggregate marks.
- c. The candidate should have undergone Basic B.Sc. Nursing / B.Sc. Hons. Nursing / Post Basic B.Sc. Nursing in an institution which is recognized by Indian Nursing Council.
- d. Minimum one year of work experience after course completion of Basic B.Sc. Nursing
- e. The candidates qualifying P. B. B.Sc.(N) from IGNOU through distance education is not eligible for M.Sc.(N) programme if the study centers are not recognized by INC.
- f. Minimum one year of work experience prior or after Post Basic B. Sc. Nursing.
- g. Only Female candidates are eligible.
- h. Admission of the candidate will be done through VNSGU, Surat
- i. Candidate shall be medically fit.
- j. 5% relaxation of marks for SC/ST candidates may be given.
- k. Candidates with 40 % -50% of lower extremity disability are eligible to apply.

6.2 ADMISSION PROCEDURE

6.2. 1. IMPORTANT INSTRUCTIONS FOR FILLING THE APPLICATION FORM AND APPEARING THE ENTRANCE EXAMINATION: -

- Before applying, candidates are advised to go through the admission instructions given therein carefully and then fill in the application form and submit the required documents mentioned in the application form.
- Candidates need to apply only through Veer Narmad South Gujarat University, Surat.
- Course details and Application Form for M. Sc. Nursing available online on Veer Narmad South Gujarat University website: www.vnsgu.ac.in
- Prospectus available at Shri Vinoba Bhave College of Nursing website: www.vbch.dnh.nic.in/www.daman.nic.in
- The candidates belonging to Scheduled Castes/ Scheduled Tribes/OBC/ EWS are required to furnish a valid certificate from the Mamlatdar.
- **No request for a change in category (General, SC, ST, OBC and EWS) applied for is entertained after the submission of the application.**

- Applicants who have not studied under Veer Narmad South Gujarat University, Surat needs to furnish the migration certificate from the university which they have passed their last examination at the time of their joining along with all other certificates in original in support of their qualifications.
- If a candidate is found to have furnished false information or certificate or concealed some information in her application, her candidature for examination/ admission will be cancelled.
- If ineligibility of a candidate is detected at any stage, her candidature for admission will be cancelled.
- Rules are subject to change in accordance with decision of the Institute, INC, GNC, University and UT administration of DNH& DD notifications taken from time to time.
- Any dispute in regard to any matter referred to herein shall be subject to the jurisdiction of DNH Civil Court alone

For In-Service Candidates (M. Sc. Nursing Course)

- The applications of in-service candidates for M. Sc. (N) must be accompanied with **No Objection Certificate (NOC)** from the Head of the Institute / Employer.(In case delay is anticipated in obtaining the **NOC**, the same can be submitted at the time of counseling). Otherwise the admission shall be rejected without any correspondence in this regard.

6.3 ENTRANCE EXAMINATION

6.3.1. PROCEDURE FOR SELECTION OF CANDIDATE

The seats will be filled strictly based on the marks secured in the entrance examination.

1. Entrance examination will be computer based, held at specified centers. The entrance examination will be conducted by VNSGU, Surat
2. Entrance Examination will be in English language only.
3. Allocation of specialty in M. Sc. Nursing will be strictly based on the marks secured in the entrance examination conducted by VNSGU, Surat.
4. No TA/ DA will be paid for attending the Entrance Examination and Counseling.

6.4 COUNSELING AND ADMISSION DETAILS:

As per VNSGU, Surat

❖ Admission

- Candidates would be admitted on the day of counseling.
- Selected candidates need to pay the fees and submit their original documents on the day of admission, failing which her selection will be treated as cancelled and seat will be offered to the next candidate on the merit/waiting list.
- Any attempt on the part of candidate to influence the management directly or indirectly will be treated as unfair means and candidate will be disqualified.
- The decision of the Counseling Committee of VNSGU in the matter of selection of candidate(s) for the course shall be the final.
- No individual intimation will be sent to the non selected candidates.

❖ **Joining Time**

Selected candidates must join the course on the stipulated date instructed by VNSGU, Surat during counseling. No extension in joining shall be granted. **The admission of selected candidates who fail to join by the stipulated date shall automatically stand cancelled and no correspondence will be entertained.** The institute takes no responsibility of intimating for cancellation of seats.

❖ **Medical Examination**

Medical fitness will be pre-condition for admission for all candidates. The candidates will be also medically examined by a Medical Board, constituted by the Institute to determine their medical fitness. (Annexure 1)

➤ **Candidates with 40%-50% of lower extremity disability need to submit the disability certificate along with the application form.**

- I. A disability certificate duly constituted and authorized by the Medical Board of the State or Central Govt. Hospitals / Institutions need to be uploaded along with the online application form and has to be produced before the Certificate Verification Committee.
- II. She should also appear before an Institutional Medical Board and obtain a valid Disability Certificate prior to admission.
- III. The suitability of the candidate against her disability will be assessed against the patient safety norms for due certification by the Medical Board.
- IV. The decision of the Institutional Medical Board is final in this regard.
- V. Candidates shall be medically fit. However, Colour Blind candidates should be considered for admission to Nursing Courses subject to the condition that Colour corrective contact lens and spectacles are worn by such candidates.

6.6. LIQUIDATED DAMAGES AND SUBMISSION OF UNDERTAKING

- The applicants selected for post graduate course shall have to submit an undertaking on Rs.50/- stamp paper at the time of joining the course to the effect that she shall not discontinue the M.Sc Nursing course she has been allotted to after the validity period of the rank list. M.Sc Nursing student who discontinues the course after the validity period of the select list, she shall pay Rs. 2 Lakh/- as liquidated damages and also repay the scholarship / stipend already received if any.

If sufficient numbers of candidates are not available to fill up the seats reserved for SC, the same seats will be filled up by ST candidates. Similarly, if sufficient numbers of candidates are not available to fill up the seats reserved for ST, the same seats will be filled up by SC candidates & Vice-versa. Thereafter, in case of non availability of suitable candidates of SC/ ST the same seats will be filled up from merit list of general category. Similarly, if sufficient candidates are not available to fill the seats reserved for OBC, then said seats will be filled in by Merit list candidates from general category.

Further, the department proposed that if seats are not filled from DNH candidates, the preference would be given to domicile candidates of Daman and Diu similarly if seats are not filled from DD candidates, the preference would be given to domicile candidates of DNH and the and if the seats are still vacant, then the seats would be filled by the open category candidates.

6.8 INSTRUCTIONS FOR JOINING THE COURSE

1. The duration of training is 2 years, strictly full time and ordinarily continuous.
2. The admission is **provisional**, subject to the issuing of Final Eligibility certificate by Veer Narmad South Gujarat University, Surat.
3. The selected candidates will have to submit the following Original **documents/certificates**:

N. B.:

1. Minimum pass marks shall be 50 % in each of the Theory and practical papers separately.
2. A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject for appearing for examination.
3. A candidate must have 100% attendance in each of the practical areas before award of degree.
4. A candidate has to pass in theory and practical exam separately in each of the paper.
5. If a candidate fails in either theory or practical paper he/she has to re-appear for both the papers (Theory and practical).
6. Maximum number of attempts permitted for each paper is 3 including first attempt.
7. The maximum period to complete the course successfully should not exceed 4 (four) years
8. No candidate shall be admitted to the subsequent 2nd year examination unless the candidate has passed the 1st year examination.

8. FACILITIES OF THE COLLEGE

College has its own well planned building as a parent hospital within the campus, to enable the nursing students to acquire knowledge through clinical experience. Students are also posted in rural health centers for their community experience.

The college has an excellent infrastructure with state of art laboratories and mannequins for initiating teaching by simulation method furnished with the latest and best available Audio Visual teaching aids such as OHP's, LCD's, Visualizer's etc. for providing teaching and learning by interactive lecturing method well supported by experienced teaching faculty with a wide range of expertise in clinical, academics and social settings.

The institution imparts not only academic knowledge but also ensures all-round development of the students through its best practices.

Ragging free environment

- ❖ As per the **University Grants Commission Act, 1956, Ragging is strictly prohibited inside the campus** and Anti Ragging Affidavit (Annexure -3) will be taken once admission is confirmed.

Library

- ❖ A well furnished spacious library with adequate number of books and journals with all the modern facilities including e- learning is available for the students within the campus.

Hostel

- ❖ Well furnished hostel and mess facilities are provided for the students within the campus.
- ❖ Application form for admission to hostel and Rules & Regulations governing stay in hostel can be obtained from the office of Shri Vinoba Bhave College of Nursing on payment of Rs.10/-

Uniform

- ❖ A distinct dress code for the students, with a sole objective to instill a sense of uniformity and also to inculcate the culture and values in them.

Cafeteria

- ❖ There is a cafeteria that serves healthy, wholesome and hygienically prepared foods.

Medicare & Dental Care (Student Health)

- ❖ Extend free services of Medicare and Dental Care to the students. Provision of highly specialized facilities like C.T scan, MRI scan and Echocardiography are also available round the clock and are provided to the students in an extremely subsidized rate.

Sports and fitness facilities

- ❖ For all round development of the students liberal arrangements have been made for indoor and outdoor games and sports facilities so as to provide them with ample competitive and recreational opportunities.

9.RULES AND REGULATIONS TO BE OBSERVED IN THE COLLEGE & HOSTEL

College of Nursing prepares its graduates to become exemplary citizens by adhering to code of ethics and professional conduct at all times in fulfilling personal and professional obligations.

1. Every student admitted to the M.Sc. Nursing course should follow rules and regulations of the Nursing College.
2. Student should intimate the head of the institution if they are on treatment for any illness.
3. Students are responsible to the management for their behavior, both in and outside the campus.
4. All decisions taken by the management are final.
5. Students must assemble in the college campus for the prayer sharp at 7.45 am every day.
6. Students are required to be regular and punctual for the class. Students are expected to be in the class at least 5 minutes before the commencement of the period.
7. Students should maintain perfect order and strict silence inside the lecture hall.
8. Movement outside the class room in between lectures should be minimum and for valid reasons only.
9. Loitering around the corridors during classes and attending other classes are not allowed.
10. Students should maintain silence in the class, library, reading room and in the corridors. Students should make every effort to take care of the college, hostel and hospital property and help in maintaining the same. They should not write on the black board, scribble on tables, chairs, walls etc.
11. Students are not allowed to come directly in the Principal's office. They can meet Principal only with the permission of the class coordinator.

12. If the students have any problem, they should inform the class representative and the class representative will intimate it to the class coordinators. If the problem is not solved at the class coordinator's level, then the class coordinator will present it to the Principal. No students should by-pass the above mentioned channels. Exceptions are allowed only if the problem is urgent/serious.
13. A student nurse is not allowed to receive gift or gratuity of any sort at any time from the patients or their relatives.
14. Students are required to maintain ethical and professional standards in behavior both inside and outside the college, hospital, hostel and community premises.
15. Each student is responsible for the proper handling and safe custody of any apparatus or equipment that she may be using in different nursing labs. Misuse or negligence will result in replacement of the particular item by the candidate. Any willful damage done to the property of the college, hostel or hospital will be treated as breach of discipline.
16. Students are not allowed to paste notices within the institutions without prior written permission from the Office of the Principal.
17. Students are forbidden to communicate with any person outside the authority without permission from the Office of the Principal.
18. Any student who damages the reputation of the college in any way is liable to be expelled. If any student discontinues the course, she shall clear all dues before leaving the college. If she fails to pay, her original certificates will be retained and will be returned once the dues are cleared by the student.
19. Violating the rules of College / Hostel will be dealt with seriously by the college authorities and if necessary dismissal from the college may be considered depending upon the seriousness of the violation.
20. The college provides transport facilities for student's field work but whenever this is not feasible, the student will have to use public transport at her own expenses.
21. When students are posted outside Silvassa for field experience / field work, expenses shall be borne by the students.
22. Rules are subject to change from time to time.

DRESS CODE:

The students are expected to attend college well dressed on all working days

1. M. Sc. (N): SVBCON: Gray color pant and Pista green color shirt with Black shoes for clinical and pink color churidar with Black shoes for classes. Hair must be put up neatly.

GCON: Light and dark purple attire with Black shoes for clinical and Rama Green color churidar with Black shoes for classes. Hair must be put up neatly.

2. Students are required to wear full uniform during college hours and clinical. Jewels, earrings, painted fingernails, threads and bracelets on hands etc. are not allowed. Students must be neat and tidy at all times.
3. Students are required to carry their identity cards during college hours, clinical and whenever they are going out and must produce whenever it is asked by the concerned authority.
4. Students are encouraged to wear simple and descent dress suitable for an academic environment during the co - curricular activities

ATTENDANCE REQUIREMENTS:

1. Regular and punctual attendance in all class activities likes lectures, demonstrations, practical's, clinical teaching, tests etc. is compulsory. Regular college time is 8:00 am – 5:00 pm. Students should participate in all college activities like clinical meetings, conferences, guest lectures, seminars as well as sports and cultural activities etc.
2. A candidate must have minimum of 80% attendance in theory and practical, in each subject for appearing in examination.
3. A candidate must have 100% attendance in each of the practical areas.
4. As per the University, INC and GNC regulations, no student shall be allowed to appear in the annual examination of the concerned subject if her theory and practical attendance is less than 80% of the total sessions.
5. Permission for leave or absence from the classes must be taken from the class coordinator and principal.
6. In case of illness, permission shall have to be obtained from the Principal to remain absent from studies.
7. The students should not be absent / take leave without prior permission from the Principal. Any unauthorized absence will be viewed seriously and liable for punishment.
8. If the student is absent for continuous period of five days, the information regarding the leave will be intimated to the guardians/ parents.
9. If the student is unable to return on time after vacation due to illness, it is mandatory to submit the Medical Certificate from the Government hospital.

10. If a student is in need to leave the college or hospital in the middle of a day, for any emergency, she should get sanction from the class coordinator and Principal. A letter to that effect must be produced from the parent or guardian.

ACADEMIC STANDARDS

1. Students should attend all tests and show good academic progress.
2. Regularity in writing tests and satisfactory performance of students in tests are essential for permitting the students to appear for the university examination at the end of the academic year.
3. Besides the curricular activities, the students are expected to participate in all extracurricular activities such as sports and cultural programmes.

DISCIPLINE OF THE STUDENTS

1. Identity Card is mandatory during College Hours and Clinical posting.
2. Rules and regulations in relation to student's discipline will be enforced effectively to maintain discipline and to keep up the decorum of the College.
3. Students should abide by the rules and regulations of the College, Hostel and Hospital strictly.
4. Ragging or any other form of indiscipline will invite strict disciplinary action from the management.
5. For any kind of misbehavior by a student or group of students with staff or creating disturbances in Classroom /College / Hostel/ Hospital premises, strict disciplinary action will be taken. A student expelled on disciplinary grounds will not be readmitted to this college.
6. Students are not allowed to use mobile phones during college/clinical hours.
7. If any student found in use of liquor or narcotics on hospital duty or in institute premises, she will be suspended from the institute for a specific period or be expelled from the institution.
8. Possession of weapons, explosives and other objectionable material in Institute/hostel will result in being expelled from the institution.
9. Breakage of the articles in the laboratory by the student(s) will be replaced by her/them.
10. Taking active part in politics will result in being expelled from the institution.
11. Involving in group discussions/ Sharing posts/ literature promoting social /communal hatred on social media platforms will result in strict disciplinary action.

12. Student reporting for hospital duty or entering the institute premises in a scruffy appearance is liable for punishment.
13. Ragging is an offense and is strictly prohibited in the college / hostel premises. Any student(s) involved in such activities will be immediately expelled from the institution. Both junior and senior students are required to maintain cordial relationship with each other and a disciplined atmosphere in the college campus.
14. Students shall be answerable for bringing any friends/relatives etc. to the college during regular classes, functions etc. without the permission of the concerned authorities.

HOSTEL RULES

1. The Management reserves the rights for admission in the hostel.
2. Hostel room will be allotted as per the availability
3. Students attendance will be taken regularly at the time of breakfast (7:00 am), dinner (8:00 pm) and before going to bed (10:00 pm) by the warden.
4. Students are not allowed to use any personal electrical appliances in the hostel.
5. Students are allowed to use mobile phones in the hostel.
6. Students are allowed to use Laptops/Tabs in both College and Hostel premises
7. Students are not allowed to keep money or valuable items in the hostel. Management is not responsible for its loss.
8. Without prior information, the authorities have right to search hostel or students personal belongings at any time to maintain discipline and decorum.
9. Lights and fans are to be switched off, when not in use and all lights should be switched off by 11 pm.
10. No outside food/ individual celebrations are permitted inside the hostel.
11. Wastage of food is not allowed in the hostel. Food should not be taken outside the dining area.
12. Students are not allowed to carry personal utensils/ Hostel Mess utensils inside/ outside the hostel mess hall.
13. The students must keep their room and surroundings neat and clean.
14. Relatives/parents/friends are not allowed to enter their respective rooms in the hostel.
15. List of relatives or visitors with photographs (who will visit the student during the Training period) has to be submitted duly signed by the parents / guardian.
16. No Visitors are allowed to visit the students on college/week days until and unless there is a genuine emergency, except on the days permitted for out-pass by the management, failing which leads to cancellation of forthcoming out pass.

17. Students are allowed to go out of the campus only on permitted days.
18. Extra leave will not be granted to any student until and unless there is a genuine emergency. The prior permission has to be obtained from the class coordinator and Principal.
19. The study hours will be from 6:30 pm to 10:00 pm (with break of 30 min for dinner) every day.
20. Students should bring the following articles at the time of joining:

21. Any damage to the Hostel property will be compensated by the student herself.
22. Ragging or any other form of indiscipline will invite strict disciplinary action from the management and any kind of misbehavior by a student or group of students with staff or creating disturbances in the hostel premises, strict disciplinary action will be taken. A student expelled on disciplinary grounds will not be readmitted to this college.
23. If any student found in use of liquor or narcotics in hostel premises, she will be suspended from the institute for a specific period or be expelled from the institution.
24. The management has the right to revise the rules & regulations from time to time.
